It is hereby notified for general information that the SECONDARY SCHOOL CERTIFICATE (SSC) SUPPLEMENTARY EXAMINATION, 2014 of the Federal Board of Intermediate and Secondary Education, Islamabad will be held with effect from **Tuesday, the 23<sup>rd</sup> September 2014.**

3. **A CANDIDATE APPEARING IN ANY FAILURE SUBJECT(S) WILL PAY FEE OF HIS/HER RESPECTIVE GROUP.**

4. The Board has launched online system for submission of its fee. This has been done to facilitate its stakeholders within Pakistan. Affiliated institutions, private or ex-students may remit their requisite fee in the nearest Habib Bank Limited (HBL) Branch. The challan slip can be downloaded from FBISE web site ([www.fbise.edu.pk](http://www.fbise.edu.pk)). Copy of challan may be attached with the covering letter/admission form. The fee could also be remitted through Pay Order/Bank Draft in favour of the Controller of Examinations (Conduct), Federal Board of Intermediate and Secondary Education, Islamabad drawnable at Islamabad and must provide the following information on the back side of the Pay Order/Bank Draft:-

5. The pre-printed Computerized Admission Forms bearing scanned photographs of failure regular candidates of SSC Annual Examination, 2014 are being sent to the Heads of Institutions concerned who will issue the same to the failure candidates along with their Result Cards. The pre-printed Computerized Admission Forms of the Ex/Private failure candidates are being dispatched on their addresses given by them in their Admission Forms.

6. The candidates failing at SSC Annual Examination, 2014, (compartmental cases) who receive the pre-printed Computerized Admission Forms shall sign the Admission Forms, deposit the required fee, enter the Bank Draft, Pay Order/Challan Number at the given place and submit to the Board. These forms will not require any attestation. However, those candidates who do not receive Computerized Admission Forms shall use normal Admission Forms, paste their Photographs, get these attested from the respective Head of the Institution affiliated with the Federal Board and submit the same with photocopy of the Result Card.

7. **NO FRESH CANDIDATE (EXCEPT APPEARING IN ADDITIONAL SUBJECTS) IS ALLOWED TO APPEAR IN SUPPLEMENTARY EXAMINATION.** However, the candidates who intend to improve their Grade/Marks can do so by re-appearing in upto two subjects of their choice/entire examination as the case may be within a period of one year of passing the SSC Part-II examination.

8. The candidates who wish to improve their grade/marks should fill in the Admission Forms along with the Application Form for improvement, which can be obtained from the Board's office on payment of Rs. 20/-. The Admission Form is also available for download at FBISE web-site [www.fbise.edu.pk](http://www.fbise.edu.pk). In this case, the cost of Admission Form i.e. Rs. 20/- will have to be remitted along with admission fee.

9. Those candidates whose result is declared late by the Board may submit their Admission Forms with normal fee within 15 days from the date of declaration of their result but before commencement of the Examination.

10. Candidates of Gilgit, Baltistan should submit their Admission Forms to FBISE's Sub Office, Gilgit, Baltistan as per admission schedule.

11. Failure candidate(s) of SSC-I Annual Examination are allowed to re-appear in the next SSC Supplementary/Annual Examination or both leaving it to their option.
